This is to acknowledge receipt of your further submission dated 15 May 2011, concerning communication No. 428/2010, which you submitted to the Committee against Torture, for consideration under article 22 of the Convention against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment, on behalf of Mr. Alexey Kalinichenko.

A copy of your submission has been sent to the State party, for comments. The Special Rapporteur on new complaints and interim measures expressed his concern at the information provided in your letter of 15 May 2011. He recalled the Committee's request, on 13 August 2010, 20 October 2010, 4 January 2011 and 11 May 2011, not to extradite Mr. Alexey Kalinichenko while his complaint is under consideration before the Committee and requested information on the circumstances of the reported extradition, the complainant's whereabouts and his state of health.
